Novena Global Lifecare Group is the holding company merging Victoria Medical and PPP Laser Clinic. Novena Global Lifecare has a network of 100 clinics across Singapore, China, Hong Kong, Taiwan, South Korea, Indonesia, India and Malaysia.

To further fuel its expansion, the Singapore-based business has announced plans to list on the Taiwan Stock Exchange to raise US\$150 million (S\$204 million).
